MOTION: The patient suffered a complication after minimally invasive mitral valve repair performed by the licensee. The patient alleges the injury occurred because the licensee allowed an unqualified Advanced Practice Professional to perform critical parts of the procedure. The licensee acknowledges the iatrogenic injury that is a described complication of the index procedure and reiterates the apology that was previously offered to the patient. The licensee asserts that he did not allow an Advanced Practice Professional to perform critical steps of the procedure. Review of the information above supports the fact that all critical elements of the procedure were indeed performed by the licensee. Peer review indicates that appropriate care was provided.

MOTION: The Board-issued complaint arose from a pharmacist's concerns about telemedicine prescribing, and subpoenaed records demonstrated charting deficiencies. In his response, the physician explained his workplace circumstances which contributed to the Board's findings and the changes in his personal prescribing habits and the improvements in his employer's Electronic Medical Record (EMR) system which have been implemented.

The guidance is as follows: It is important to always provide thorough documentation of all clinical encounters regardless of the limitations of the EMR vehicle, the practice setting, or employer factors.

MOTION: The complaint was initiated after review of AD23-234, which stemmed from a license suspension of the licensee's Minnesota medical license in 2023. Since that time, the Minnesota Board did a thorough investigation and found that the suspension was not due to any substandard care by the licensee and unanimously overturned any license suspension. The complaint also alleges that the licensee failed to report the information surrounding the suspension within the required 10 days. Based upon the information in the Minnesota investigation, dismissal of the complaint is appropriate.

MOTION: The licensee was removed from a hospital's emergency medicine roster based on an allegation that the licensee struck a patient while providing care. The patient had delirium with agitated behavior that required some restraint in the emergency department. At the Board's request, the licensee underwent an evaluation which did not identify any significant mental health illness or substance use disorder with no recommendations for referral or further treatment. The licensee denies all claims that his treatment was inappropriate and feels his actions were necessary to maintain safety. Two witness accounts and the hospital report to the Department of Health and Human Services indicate that his treatment was inappropriate. The Board requested the licensee take a CME course and he completed a Management of Aggressive Behavior course. He appropriately reflects on how he could have communicated better with the care team to avoid confrontation and physical force and will employ his learnings moving forward.

MOTION: The complaint arose from a patient's concern that the physician identified abnormal findings that she wished to refer to a gynecologic oncologist, but she did not complete her documentation of the visit or make the required referral until more than two weeks later, and then only after the patient called her clinic and inquired about the referral. The physician completed her documentation of the visit and initiated the referral later on the day that the patient called.

The guidance is as follows: It is very important to complete documentation of clinical encounters in a timely fashion, in order to ensure the accuracy of patient chart entries and the accessibility of visit information to others, and to avoid delays in patient care.

MOTION: The patient alleges that the licensee discriminated against him due to his history of substance use disorder and failed to treat him appropriately for a skin infection. The patient was treated with Bactrim for a cellulitis that developed about a week after sustaining a dog bite injury. The medical record and licensee response does not support any discrimination or unprofessional treatment of the patient based on his history. However, the choice of antibiotic for this type of infection should have been broadened to include anaerobic coverage and reflects an opportunity for improvement in care. The Board requested that the licensee take CME regarding soft tissue infections and appropriate management. The licensee completed the requested readings and submitted an appropriate response regarding what she learned and impact on her future practice.

MOTION: The licensee provided Emergency Department (ED) care to a patient with end stage kidney disease (on dialysis), bipolar disorder and acute mania. The stay in the ED was prolonged and during the stay a consulting physician ordered an increase in a medication from once a day to twice a day (doubling the dose). Later, another consultant recommended cutting the dose back to once a day. A different ED provider entered that order but did not discontinue the prior, twice a day order, which resulted in a tripling of the patient's original dose. When the patient requested discharge this licensee had assumed care for the patient and verbally ordered that the prescription be sent to a pharmacy because the patient did not have the med at home. The error was discovered when a regular specialty provider saw the patient in follow up and notified the licensee. The licensee's response shows appropriate insight into the role she played in the error. Outside expert review notes that it is primarily a systems error and that the licensee met the standard of care.

MOTION: The complaint arose from a patient's concern that the physician was unprofessional in his communication during her visit, was inattentive to her requests, and used inappropriate humor. After considering the physician's response, the Board asked that he voluntarily attend a course on professional communication. He did so and submitted a statement of what he learned from the course regarding his chosen focus area: giving patients bad news.

The guidance is as follows: Patient communication is an essential skill in the practice of medicine and use of inappropriate humor can be particularly damaging to patient relationships. Regularly engaging in self-evaluation of one's communication style and practices, assisted by colleagues who regularly observe your patient interactions, affords valuable opportunities to assess whether one's communications are being received as intended, and whether those communications meet the requirements that they are clear, compassionate, and appropriate. You are encouraged to continue to be mindful and self-reflective regarding effective and appropriate communication with patients, and to be particularly mindful of any use of anecdotes or references that may seem humorous to an individual practitioner, but which may be inappropriate or offensive to a patient or colleague. Attached you will find, "Communicating with Patients: Guidelines from the Maine Board of Licensure in Medicine."

The physician's response indicated that there were no complaints or findings that would suggest infection. Board review of his records demonstrated no recorded physical exam pertinent to the patient's complaints in visits prior to patient hospitalization. Although it is unlikely that the infectious etiology was active at the time of his visits with the patient or that the infectious etiology could have been diagnosed at those visits, records should contain appropriate focused physical examination notes.

The guidance is as follows: At every clinical encounter, it is important to perform and document physical examination appropriate to the presenting complaint.

The complainant declined due to feeling "ambushed." The licensee indicated that the provider proceeded to speak with the complainant despite her refusal. She said the complainant became upset and left the exam room only to return a short while later. The licensee apologized to patient and offered options for the complainant to feel safe. Since that interaction, the licensee had registered for additional CMEs on Trauma Informed care for additional competency development in this area. The review of the records and accompanying documentation shows that the licensee made an effort to provide as reassuring a visit as she can as this visit was due to previous unresolved resolution to another concern about another provider raised in prior appointments. The licensee recognizes the importance of understanding and appreciating the nature of trauma in healthcare and she went on to obtain additional CMEs on the topic.
