

On May 15, 2024, the Pequawket Valley Educators Association (PVEA) and Pequawket Valley Support Staff Association (PVSSA) filed a petition for Bargaining Agent Merger Election with the Maine Labor Relations Board. Each petitioner currently represents its own bargaining unit. The petitioners requested an election in order to merge into a single bargaining agent named the Pequawket Valley Education Association. Thereafter, the Board scheduled a Bargaining Agent Merger Election by mail ballot to be conducted between June 17, 2024, and July 9, 2024, among employees in the bargaining units represented by the petitioners. On June 3, 2024, the Board provided the petitioners and MSAD No. 72 with sample ballots and a notice of election for both informational and posting purposes. On June 17, 2024, the Board mailed ballots to all members of the unit included in the list of eligible voters prepared by the employer.


