CALL TO ORDER

Board Chair, Jennifer King, called the meeting to order at 9:03 a.m.

MINUTES REVIEW AND APPROVAL

Review and approval of the June 24, 2024 minutes.

A motion was made by Holly Cavna and seconded by Ellen Grunblatt to approve the minutes as written.

COMPLAINT PRESENTATIONS

2023-COU-19378

A motion was made by Ellen Grunblatt and seconded by Joanne Grant to dismiss this complaint due to the lack of evidence of a violation of Board laws or rules.

2024-COU-20002

A motion was made by Carolyn Silsby and seconded by Jennifer King to set this matter for an adjudicatory hearing and offer a consent agreement, in lieu of a hearing, citing Board rules Chapter 8-A 4(2) (sexual relationship), 2(1) A & B (dual relationship) and 5(1) (client records), with: a reprimand; a revocation of licensure; and preconditions for any future applications, which will include: the agreement that the licensee will not reapply for licensure for at least 1 year; will engage in 12 months of supervision, meeting once a month, with a Maine licensed clinical mental health professional who will submit a final report of the supervision along with the supervision dates; and the completion of at least 12 hours of continuing education (in-person or synchronous online) in addition to the standard continuing education requirements for licensure, that will include 6 hours focusing on ethics (including record keeping) and 6 hours focusing on dual relationships and will be documented by completion certificates and course outlines.

A motion was made by Ellen Grunblatt and seconded by Angela Blier to set this matter for an adjudicatory hearing and offer a consent agreement, in lieu of a hearing, citing Board rules Chapter 8-A 2(1)A (dual relationship), with: a reprimand; a minimum of 12 months of probation, with 1 hour of supervision a month, focusing on boundaries, dual relationships and disclosures with any AAMFT approved supervisor who has been licensed at least 5 years and is in good standing, who will submit quarterly and final reports to the Board for approval; and the notification to the licensee's employer of this consent agreement.
