A motion was made by Ellen Grunblatt and seconded by Carolyn Silsby to set this matter for an adjudicatory hearing and offer a consent agreement, in lieu of a hearing, siting Board rules Chapter 8-A (2)1 A & B (dual relationship), (2)5 (referral), 2 (client relationship), (2)6 (termination), 4(5) (inappropriate environment), 4(6) (impairment), 4(10) (gifts), 5 (records) and 6 (confidentiality), with: a reprimand; the licensee's continued engagement in her personal counseling services, until her provider determines a clinically appropriate discharge of services, during which the licensee will submit annual attendance records of these services and notify the Board of discharge of this service; 12 hours of synchronous continuing education hours, including 6 hours in professional and ethical boundaries and 6 hours in dual relationships, to be obtained in day-long, 6-hour trainings (pre-approved by Angela Blier outside of a regular Board meeting) that will be completed within 1 year of the start of the probationary period; and 3 years of probation which will consist of: 90 minutes of synchronous individual supervision per month, with a focus on professional and ethical boundaries, dual relationships, countertransference, self-care, and ethics and technology, with a Boardapproved Maine licensee (approved by Ellen Grunblatt outside of a regular Board meeting) who has been in good standing for the last 5 years, has experience supervising for at least 5 years and holds a clinical license (counselor, social worker or psychologist), who will submit quarterly and final reports to the Board and will be provided with as much of this complaint's materials as legally possible.
