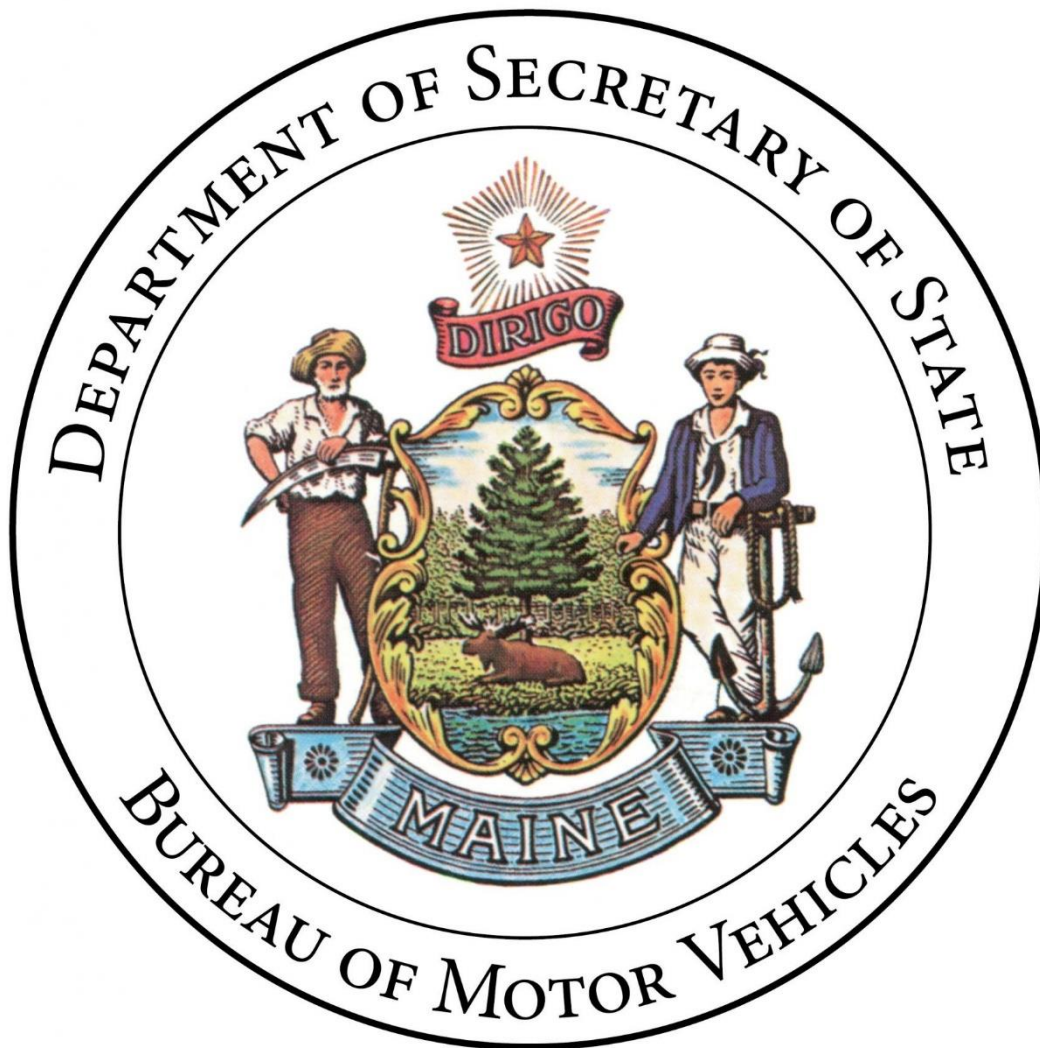

# Maine's Electronic Lien Titling Technical Specifications

## Introduction

This document outlines the technical specifications for the computer interface required for conducting title transactions as part of Maine Electronic Lien Titling Program.

## Planned Phases of ELT Development

Maine Bureau of Motor Vehicles (MBMV) is developing the ELT in four phases. Each phase will implement new features and transactions. The specifications in this document pertain to Phase I.

MBMV's plans for future development are outlined below:

### Phase I—estimated implementation date 01-31-2024

During Phase I all transactions will be conducted through a SFTP batch interface.

Transactions in development for Phase I:

- Lien notification from MBMV
- Lien release by lienholder
- Change owner address by lienholder
- Request for printed title by lienholder
- "Mail to" alternate address
- Request from lienholder for update or correction to title
- Notification from MBMV of update or correction to title

### Phase II—estimated implementation date 01-31-2026

MBMV will integrate a REST API for the purpose of conducting ELT transactions.

Anticipated Phase II transactions:

- Title inquiry by lienholder
- Electronic title applications
- Electronic payments
- Reassignment of lien
- Convert paper titles to ELT record
- Lease assumptions
- Salvage titles
- Option for vehicle owner to keep electronic title after lien release

### Phase III—planning to begin 02-01-2026

MBMV expects to develop new transactions in consultation with stakeholders for Phase III.

### Phase IV—planning to begin 02-01-2028

MBMV expects to develop new transactions in consultation with stakeholders for Phase IV.

- Goal: fully electronic title system

# Maine's Electronic Lien Titling Technical Specifications

## Transaction Descriptions for Phase 1

Transactions will be limited to the following titles:

1. Vehicle
2. Trailers
3. Manufactured Homes
4. Tiny Homes

MBMV may send 9 types of transactions to the lienholder:

1. An e-title recording the lien.
2. A correction to an existing e-title that the lienholder holds.
3. Notification an e-title has been replaced by a new e-title (name change/additional lien/vehicle brand added).
4. Rescind transaction (an e-title record transaction sent in error).
5. Confirmation of a "mail to" address change.
6. Confirmation of an owner address change.
7. Confirmation of the lien release.
8. Confirmation of the lien release AND "mail to" address change AND/OR owner address change.
9. Confirmation that the request to have the title printed has been received without lien release.

Lienholder may send 10 types of transactions to the MBMV:

1. Confirmation that a new e-title has been received.
2. Confirmation that a correction to an e-title has been received.
3. Confirmation that a replaced e-title transaction has been received.
4. Confirmation that a rescind for an e-title transaction has been received.
5. Request to add a "mail to" address (name and address where the paper title will be mailed).
6. Request to change the owner address on the title record.
7. Request to release the lien.
8. Request to release the lien AND add a "mail to" address AND/OR change the owner address.
9. Request to convert the e-title to a paper title and mail due to repossession.
10. Request to convert the e-title to a paper title and mail due to the owner retitling out of state.

# Maine's Electronic Lien Titling Technical Specifications

## Field Information

- MBMV stores most of its data in upper case, however, it will accept data in mixed case and convert to upper case as required.
- MBMV will send data as it is stored in our systems.
- Files will be sent csv format (comma-separated values).
  - Fields are separated by commas (,).
  - Field delimiter is a double quote (").
  - Double quotes are escaped with an additional double quote ("").
- Service Provider ID number format will be: SP-FEIN-XXX.
- Lienholder ID number format will be: ME-FEIN-XXX.
  - MBMV will accept provider numbers and lienholder numbers with hyphens (-).
- Zip Code format is the five preceding numbers and the trailing four with hyphen. Format will be: XXXXX-XXXX
- Date/Time field format is YYYYMMDDHHmmSS (20230701231922).
- Date field format is YYYYMMDD.
- Number fields can be received with or without leading zeros.
- Number fields will be sent without leading zeros.
- Title Status field codes:
  - **A**=ACTIVE
  - **C**=CANCELLED
- Miles/KM codes:
  - **E**= EXEMPT
  - **K**= KILOMETERS
  - **M**=MILES
- Mileage Type codes:
  - **A** = Actual

### Transaction Error Codes

If a service provider experiences an error while using the batch interface, they should send an email detailing the nature of the problem to [elt.bmv@maine.gov](mailto:elt.bmv@maine.gov).

If a lender notes incorrect information on an e-title, they should send an email detailing the error and including the relevant title number to [elt.bmv@maine.gov](mailto:elt.bmv@maine.gov). The Division of Title Services will research the error and issue a correction accordingly.

If a lender experiences trouble connecting to provider's batch interface, they must contact the provider to correct the error. They may not contact BMV.

In case of an error in MBMV will send the following error codes either in a confirmation transaction, or, where it is not possible to send a confirmation transaction, in an error (ERR) transaction:

## File Transfer Schedules

MBMV and providers are required to retrieve files seven days a week including holidays.

Providers retrieve outbound files from MBMV and delete them after successful retrieval between the hours of 12:00 am and 01:30 am EST.

Providers must have inbound files available for MBMV retrieval by 11:00 pm (23:00) EST each evening. MBMV retrieves the files and deletes them after successful retrieval between the hours of 12:00 am and 01:30 am EST.

Providers must notify the MBMV contact person immediately upon discovery of the failure to retrieve outbound files or submit inbound files. This notification shall occur within 24 hours of the failure during MBMV business hours.

## Data Transfers

### Required File Transfer Protocol

The BMV requires all external data transfers to be encrypted end-to-end using PGP encryption. The connection will also be encrypted using SFTP. SFTP-Secure File Transfer Protocol uses Secure Shell (SSH) communications technology to secure the control and data connection. We will be exchanging public PGP keys with each Service Provider and require a SSH key for connections to the FTP site.

BMV uses MOVEit.

## Standards and Conventions

**Inbound files** (identified on pages 15-18) will be named in the following manner:

TITLE.ELT.IN.<SP ID# without hyphens>.YYYYMMDD.HHmss where SPID# is the service provider identification number (without hyphens) assigned by MBMV and YYYYMMDDHHmss is the calendar date/time the file is created. (e.g., an inbound file for June 30, 2023 for service provider SP-123456789-001 would be named TITLE.ELT.IN.SP123456789001.20230330.171959).

**Outbound files** (identified on pages 11-15) will be named in the following manner:

TITLE.ELT.OUT.<SP ID# without hyphens>.YYYYMMDD.HHmss where SPID# is the service provider identification number (without hyphens) assigned by MBMV and YYYYMMDDHHmss is the calendar date/time the file is created. (e.g., an outbound file for June 30, 2023 for service provider SP-123456789-001 would be named TITLE.ELT.OUT.SP12345679001.20230630.171959).

**Encryption** BMV use PGP Encryption and all files are encrypted/decrypted using GnuPG with a .pgp extension.

## Communication and System Testing for Phase 1

Upon review of the Maine ELT Service Provider Application & Service Provider MOU, the service provider, if interested in participating in Maine's ELT Program, will initiate a meeting with the Maine Division of Title Service's contact person. This meeting can be via Zoom, Teams, conference call, or in person at the MBMV. MBMV will invite other staff as needed i.e., Office of Information Services Architects, Analysts, etc.

Providers will communicate through the designated BMV contact person for all testing and error resolutions.

## Test Cases

### Test Case 1 NET and CET Codes

Certificate of Title Application (CTA) has been received by the BMV and the lien has been perfected:  
MBMV will send a NET transaction & SP will reply with a CET transaction

### Test Case 2 MCT and CCT Codes

MBMV makes a correction to the title record due to:

1. Lienholder finds and reports an error in the e-title. Service Provider emails the [elt.bmv@maine.gov](mailto:elt.bmv@maine.gov)
2. MBMV finds an error on the title record.  
MBMV will send a MCT transaction & SP will reply with a CCT transaction

### Test Case 3 MRC and CRC Codes

MBMV replaces a title record to correct data due to:

1. Lienholder finds and reports an error in the e-title. Service Provider emails the [elt.bmv@maine.gov](mailto:elt.bmv@maine.gov)
2. MBMV finds an error on the title record.  
MBMV will send a MRC transaction & SP will reply with a CRC transaction

### Test Case 4 MRT and CRT Codes

MBMV wants to cancel the NET e-title "transaction" for various reasons:

MBMV will send a MRT transaction & SP will reply with a CRT transaction

### Test Case 5 LMA and CMA Codes

Lienholder wants to add a "mail to" address to the title record

SP will send a LMA transaction & MBMV will reply with a CMA transaction

### Test Case 6 LOA and COA Codes

Lienholder want to change the owner address on the title record

SP will send a LOA transaction & MBMV will reply with a COA transaction

### Test Case 7 LLR and CLR Codes

Lienholder wants to release their lien on a title record (to release multiple liens on the same title record multiple transactions well need to be sent)

SP will send a LLR transaction & MBMV will reply with a CLR transaction

### Test Case 8 LLW and CLW Codes

Lienholder want to release the lien AND add a "mail to" address AND/OR change the owner name on the title record (to release multiple liens on the same title record multiple transactions will need to be sent)

SP will send a LLW transaction & MBMV will reply with a CLW transaction

### Test Case 9 LPR and CTP

Lienholder wants to have the e-title converted to a paper title due to a repossession  
No lien release

SP will send a LPR transaction & MBMV will reply with a CTP transaction

### Test Case 10 LOP and CTP Codes

Lienholder wants to have the e-title converted to a paper title due to the owner moving out of state

No lien release

SP will send a LOP transaction & MBMV will reply with a CTP transaction

Upon successful completion of the testing, the Office of Information Services will report the test results to the Division of Title Services. The Division of Title Services will then add the provider to the list of authorized providers and will communicate with the provider to determine an implementation date.
